

New cdcbaa Message Board-HOW TO REGISTER

- 1) Go to this url: <https://www.cdcbaa.org/> (Note if you were a beta test this is a different url)
- 2) If you were a beta tester your prior beta testing login info should work. If you were not, then you will need to register. Pretty Self Explanatory BUT I will say that the user name you select will be your display name for the Message Board (you should not use email address but what is recommended is your name and spaces are ok—your call but this is how other members will be able to identify you)
- 3) The email you put in your registration will be the email address you will receive post to emails (if you want this feature) and it will have to be the email you use to do email to post. In other words if your registration email is janelawyer@bk.com and you send an email to post from say janelawer@home.com your message will not post (and you will not receive posts on the @home.com email).
- 4) Email to post is sent to: message@cdcbaa.org

After Registration (Settings to review in your User Control Panel (UCP))

- 1) If you want posts to be sent to your designated email (and reply from your email) —like our old Listserve on yahoo.groups functionality. Make sure:
 - a. Go to your **UCP** (top Right-click your username then you will select UCP)
 - b. In the UCP at the menu ribbon Go To **Board Preferences** (after Profile)
 - c. On the left select **Edit Posting Defaults**- Make sure **Notify Me Upon Replies** is selected **Yes** (as it defaults to No). Then press **Submit** (If you do not want to receive email post then make sure this is set for No)
 - d. Next (still in Board Preferences) Go To **Edit notification options** (this is 2 down from Edit Posting Defaults—on the left side menu)
 - i. Here you will want to make sure at least the following options have **email** checked:
 - Someone replies to a topic to which you are subscribed;
 - Someone creates a topic in a forum to which you are subscribed;
 - Someone replies to a topic to which you are subscribed**NOTE:** there are other features you might want to select to receive email (e.g. Private Message or Someone quotes you) but the above is merely basic to make sure the email to post is working correctly for you
 - ii. **If you don't want to receive email to posts** then you can not select email for the particular category in the Edit notification options.
- 2) Final Step to Make Sure you Don't miss Posts. Make sure you are subscribed to the Fourm(s):
 - a. Go To **Overview** in your UCP (next to Profiles)
 - b. On the left menu you will see **Manage Subscriptions** (below **Frontpage**). The default Subscriptions you should be subscribed to are (under Watched Forums): **NEWS** (read only as used by President/ Admins/Moderators to Post Board New/Info); **Questions**; **Office Space**; **Referral**; **Yahoo Old Posts** (read only as this is achieve of our old Listserv-achieve is only up to last year as no practical way for us to get posts after December 2020 because of Yahoo restrictions).

- c. What if a Forum is missing under you Watch Forums? First, you will not receive any email notifications of post replies for that particular forum (regardless of your above notification settings). To add a missing Forum please do the following:
- i. In upper left Go To home which would be **Board Index** (this will take you to the Forums page). **Select the Forum missing** in your Watch Forums.
 - ii. Next go to the very bottom of the posts and you will see a wrench icon (bottom left). Press on the **down arrow** and select the text with a check that says **Subscribe forum**. You should have a window pop up says you are now subscribed, and it will now show up in your Watch Forums section of your UCP.
